## Important Notice To All Members

### Membership Definitions:

#### **Full Member:**

Defined as a person who holds a valid competition licence (entrant and/or competition licence) issued by the Confederation of Australian Motor Sport (CAMS) **OR** a person who is eligible to make an application to CAMS for such a licence. A full member has voting rights and shall pay the annual membership fee as determined in accordance with Rule 6 (1) of the rules of the club.

#### **Associate Member:**

Defined as a person who is either the spouse, partner or child of a full member. An associate member has no voting rights and is not eligible to apply for a competition licence through the Club and is not required to pay any membership fee.

#### **Senior Member:**

Defined as a person now retired from motor sport who previously had been actively involved in motor sport as an entrant, competitor or official. A senior member has voting rights and shall pay the annual membership fee as determined in accordance with Rule 6 (1) of the rules of the Club.

#### **Social Member:**

Defined as a person who has a keen interest in motor sport with no intention of becoming a competitor but who wishes to participate in the social activities of the Association. A social member has no voting rights and shall pay the annual membership fee as determined in accordance with Rule 6 (1) of the rules of the Club.

Being a member of the Historic Racing Car Club (Qld) Inc –

1. offers you the opportunity to participate in motor racing events either as a competitor or assisting in the running of events;
2. provides a forum for the exchange of technical information, literature and spare parts so that Historic Racing Cars can be preserved, restored, maintained, reconstructed and used in the best historic tradition;
3. allows you to partake in monthly meetings at the VACC Club premises at 1376 Old Cleveland Road, Belmont, on the 3<sup>rd</sup> Monday of each month, commencing with a BBQ at 6.30 pm;
4. provides you with the Club's monthly newsletter which will keep you up to date on coming events, Club news and items of interest;
